



# Spring 2026 Little Free Library (LFL) Read in Color Expansion Grant GRANT APPLICATION GUIDELINES and EXPECTATIONS

#### **Purpose**

"Today, in the United States, more than 30 million adults cannot read or write above a third-grade level. Studies have repeatedly shown that books in the hands of children have a meaningful impact on improving literacy. The more books in or near the home [and in the community], the more likely a child will learn and love to read.... Little Free Library book-sharing boxes play an essential role by providing 24/7 access to books and encouraging a love of reading (www.littlefreelibrary.org)."

"Read in Color® brings diverse books to Little Free Library (LFL) book-sharing boxes around the world. Read in Color distributes books that provide perspectives on racism and social justice; celebrate BIPOC, LGBTQ+, and other marginalized voices; and incorporate experiences from all identities for all readers. Less than 25% of children's books depict non-white characters. We believe everyone should be able to see themselves in the pages of a book. We also know that books can be a window into experiences that are different from our own. By reading diverse books, we can increase understanding, empathy, and inclusion (www.littlefreelibrary.org)."

Award:

One (1) Little Free Library (LFL) sharing-box, One (1) post and ground screw or set of legs for planting the LFL, One (1) box of 25 diverse books. Access to unlimited books via The Foundation's Exchangerees.

## **Key Criteria & Eligible Projects:**

Review and award of grant materials will be based on the project's anticipated need of supplies, resources, and opportunities/experiences to fulfill community needs and improve literacy rates.

Grant expectations:

- Submit an application (electronically) on or before October 31, 2025 at 5:00 p.m.
- Identify a Steward who will commit to maintaining and caring for the Little Free Library (LFL).
- Submit a photo with the desired mulched location for the LFL circled and the name of the establishment printed (e.g., Battle Grove Elementary School printed on the photo and the mulched spot by the playground is circled).
- Attend the LFL Grant Orientation for Stewards and Team Members from 5:30 p.m.-7:00 p.m. on **March 18**, 2026, at the Exchangeree Windsor Mill.
- Plant the granted LFL in the community: at a school, office, or other community location on or before <u>June</u> 14, 2026.
- Ensure the Little Free Library Charter Number plaque is attached to the front of the Little Free Library.
- Plan and execute a ribbon cutting ceremony to officially open the LFL.
- Work with Dr. Heather Wooldridge, Associate Director of The Education Foundation of BCPS, to transfer the LFL Charter Number to the Steward and to register the LFL on the Little Free Library World Map (www.littlefreelibrary.org/map/).
- Keep the Little Free Library stocked with diverse books.
- Submission of Recipient Grant Project Summary and Storyboard to The Foundation on or before <u>June 14</u>,
   2026.

Projects must be conducted and supervised by a BCPS staff member or Baltimore County community member. Projects must address an identified need that is aligned with BCPS goals, The Education Foundation of Baltimore County Public Schools, Inc.'s mission and vision, and the school's progress plan (if applicable). The proposal must describe a quantitative and/or qualitative method to evaluate the project's success.

Notification of Recipients:

Recipients will receive an e-mail notification from the foundation's Associate Director, Dr. Heather Wooldridge, on or before **November 17**, 2025. A media release/Mission Moment blog post and announcement on <u>The Education Foundation of Baltimore County Public Schools website</u> and all social media outlets will be released the week of **November 17**, 2025.

Awarding of Materials:

Materials will be provided to Stewards at the mandatory Orientation on March 18, 2026 at the Exchangeree in Windsor Mill.

All LFLs must be planted in the ground and opened with a Ribbon Cutting ceremony on or before June 14, 2026.

Proposal Review:

Proposals will be competitively reviewed by the Programs and Allocations Committee of The Education Foundation of BCPS, Inc. BCPS curriculum and instruction and/or business services professionals may be consulted as part of the proposal review for the purpose of compliance and alignment. All applications will be scored by three committee members.

Initiative Summary:

A final project summary and storyboard with photos and grant highlights must be submitted to The Education Foundation of BCPS, Inc. upon the conclusion of the initiative no later than <u>June 14, 2026</u> (A Little Free Library Read in Color storyboard template will be sent electronically to the grant recipient in the congratulatory e-mail notification).

A grant recipient who does not submit a final project summary and storyboard will not be eligible for future funding consideration until both have been received.

  - Who will serve as the Steward of your Little Free Library (LFL)? Why was this person chosen?
  - Where will your LFL be planted? (School's must plant their LFL in a mulched garden bed if planted outdoors). Take a picture of the location, print it, write the name of your school/office/business/organization on it, and circle the exact location you wish to plant your LFL.
